## Requirements for boarding

I hereby understand and agree:

- ⤴ All animals must be current on all vaccinations. I must provide vaccination history. Those pet(s) not current on all vaccinations may only board if vaccinations are given at time of drop-off.
- ⤴ All animals must be free of external parasites (ex. Ticks, fleas, etc.), or they will be treated at owner's expense.
- ⤴ All animals are required to have fecal tests preformed at the time of drop-off (or within 2 weeks of boarding) to exclude external parasites (as above).
- ⤴ Avian pet(s) are required to have an annual chlamydia test along with fecal tests.
- ⤴ Dayton South Veterinary Clinic has my permission to administer tranquilizers if necessary for treatment or handling.
- ⤴ That reasonable precaution will be used by Dayton South Veterinary Clinic against injury, escape, or death of my pet(s).
- ⤴ Dayton South Veterinary Clinic and its staff will not be liable for problems that develop, provided reasonable care and precautions are followed.
- ⤴ That any problem that develops will be treated as deemed best by the veterinarian and I assume full responsibility for the treatment and expense involved.
- ⤴ That if I neglect to pick up my pet within 5 days of the date of this agreement, you may assume that the pet is abandoned and you are hereby authorized to dispose of my pet as you may deem best and necessary.
- ⤴ **Pets must be picked up and dropped off between 8:30 and 11 am or between 2 and 6 pm Monday through Friday, and 8:30 to 11:30 on Saturday. No exceptions.**
